The regular meeting of the Committee of the Whole was called to order at 7:21 p.m. by Mayor Pruyn.

4. Committee of the Whole Meeting Minutes of December 19, 2017

11A. Resolution 1014-18

Trustee Madaras moved to approve Resolution 1014-18, A Resolution Authorizing Acceptance of a Quote From iTouch Biometrics for a Livescan Fingerprinting System in the amount of \$18,960.00 for the police department; Trustee Leahy seconded the motion. Motion carried by unanimous voice vote.

12. Public Works/Infrastructure Committee - Trustee Aiani, Chair

12A. Resolution 1012-18

Trustee Aiani moved to approve Resolution 1012-18, A Resolution Authorizing Execution of an Intergovernmental Agreement Regarding Construction Work on the Devon Avenue Bridge over Illinois Route 290 for final Village costs; Trustee Hower seconded the motion. Trustees Latoria and Santorsola opposed. Motion carried by majoriy voice vote.

12B. Resolution 1013-18

Trustee Aiani moved to approve Resolution 1013-18, A Resolution Authorizing Approval of a Final Cost Letter for Illinois Tollway Contract I-13-4608 in the amount of \$78,575.84 for; Trustee Hower seconded the motion. Trustees Latoria and Santorsola opposed. Motion carried by majority voice vote.

12C. Tollway Land Conveyance

The Illinois Tollway discovered a corner of the Tollway bridge near Hamilton Partners is on Itasca property and after further review of the whole corridor and found other areas in three communities. Trustee Aiani moved to recommend for concurrence with additional land conveyance to the Illinois Tollway in an additional \$24,700.00 of land acquisitions credits to be used by the village to reduce enhancement expenses; Trustee Leahy seconded the motion. Trustees Latoria and Santorsola opposed. Motion carried by majority voice vote.

12D. Highland Gate Sanitary Sewer

Trustee Aiani presented for discussion the Highland Gate Sanitary Sewer connection options. The options are DuPage County, Medinah Woods, a new left station, or a new gravity sewer system installed around existing DuPage County infrastructure. Initial Board consensus was to approve a lift station paid for by the developer and to continue the Village's history of not approving connection into DuPage County.

12E. West Reservoir Pump Station

Trustee Aiani moved to approve payment estimate 2 and final for the 2017 West Reservoir Pump Station improvements in the amount of \$9,788.00 to Sweeney Electric Company as recommended by staff; Trustee Leahy seconded the motion. Motion carried by unanimous voice vote.

12F. Willow Street Storm Sewer Project

Trustee Aiani moved to approve payment estimate #2 and final for the Willow Street Storm Sewer Project in the amount of \$28,720.35 to Mauro Sewer Construction, Inc. as recommended by staff; Trustee Leahy seconded the motion. Motion carried by unanimous voice vote.

12. Department Heads Reports

Safety Director O'Connor reported speaking at the Itasca Lions Club meeting in January 2018; a note was received from an elderly couple praising Officer Andrew Serio who responded to their 911 inquiry; the Police Department will be holding training classes for Highland Society staff for the Highland Games; a recent drug arrest included traces of fentanyl on material; and a man who stole from an Itasca residence has been arrested and charged with residential burglary and elderly crimes.

Community Development Director Hill report the Itasca Fire Protection District 1 now has a full-time staff member to provide inspections for the Village within 48 hours; and the Plan Commission's February 2018 meeting will feature two or three public hearings with Pulte Homes being continued until the March 2018 meeting at Village Hall.

Engineering Consultant Wesolowski had no report.

Public Works Director Hitchcock had no report.
