For Special Counsel Services with Respect to Small Wireless Facilities Deployment Act". Community Development Director Hill explained the municipal code and zoning ordinance need to be updated to comply with the State of Illinois Small Wireless Facilities Deployment Act. The law firm has experience advising municipalities with the new law and can move the Village quickly to compliance. Tentative attorney fees are \$5,000.00. Public Works Director Hitchcock reported DuPage County is assisting the Village with cleaning out storm sewers; a beaver dam in the Springbrook Creek north of Industrial Drive was located and notched; final grading on the north side of the Metra parking lot was completed and the south side will be graded next; a bid opening for the final phase of the Springbrook Nature Center project will be Wednesday, August 1, 2018; and the 2009 rear year policy will be modified for reviews to be at the Committee of the Whole Meeting instead of the Infrastructure Committee.

Village Administrator Ergo will be attending meetings regarding changes to the Surface Transportation Program along with village engineers. Village Engineer Fundich added the changes will not impact current Itasca projects that already have completed funding.
